

OCI REGISTRATION IN LIEU OF PIO CARD

OCI Registration for Current PIO card holders

As per the Indian Government guidelines, all valid PIO-card holders should now register to become an OCI-Card holder. You will be required to surrender your PIO card after your new OCI card is ready.

- If you have multiple applications to submit, kindly book separate appointments for each application.
- Kindly **carry originals** of all relevant documents that are applicable for reissue of your passport for verification purposes.
- If your situation is not indicated below, kindly clarify with our email attcons.thehague@mea.gov.in
- Each appointment is slotted for a maximum of 15 minutes.

It is important that you are ready with your supporting documents arranged in order as indicated in Checklist to ensure that we can serve you and everyone within an expected waiting time limit.

- We will be unable to accept incomplete/incorrect applications.

- 1 **Online OCI Registration (In Lieu of PIO) Application form fully filled, printed in colour, Part B completed, photo, signature and documents uploaded online <https://ociservices.gov.in/>**
- 2 **Four photographs conforming to Indian Government norms as per specifications mentioned on our website (5 cm * 5 cm)**
• **Photographs and Photocopy facility is not available in Embassy.**
- 3 **Original passport and a copy of the same**
• Note that your passport must be valid for a minimum of 180 days in order to submit your application
- 4 **Original PIO card and a copy of the same (first page, last page and copy of any endorsements)**
5. **Prepaid self-addressed Envelope (Mandatory in all cases) for return of Ready Passport or documents must be provided with the application. [Click here for customized link for generating Return DHL Waybill](#) from Consular wing, Oranjestraat 12, 2514 JB, The Hague to the respective Residential address.**

If the applicant is minor

- **No objection letter** signed by both parents
- Passport copy of both parents
- OCI/PIO Card copy of both parents (if applicable)
- Residence card copy of both parents (if applicable)

If the applicant has changed their address

- Original extract (uittreksel) issued by respective municipality in Netherlands for residence proof with address, Apostilled
