

APPLY FOR INDIAN VISA

Type of Document	Indian Visa is the essential type of document issued by Indian Mission for travelling to India.
How to Apply	<p>(1) Fill up the form online (https://indianvisaonline.gov.in/) then take a print out of online filled in application form. The form should be duly signed with photographs and accompanied with the necessary documents.</p> <p>(2) All the applicants seeking Visa services should see the below check-list for details.</p> <ul style="list-style-type: none"> a) Employment Visa- link b) Transit Visa- link c) Tourist Visa- link d) Conference Visa – link e) Business Visa – link f) Entry Visa – link g) Journalist Visa – link h) Diplomatic/Official Visa – link i) Medical/Medical Attendant Visa – link j) Ayush/Ayush Attendant Visa- link k) Student Visa – link <p>(3) Take a print out of the relevant check list in your case from S.N. 2 above and complete documentation as per the check list. Please ensure that this printed check list is placed on top of the all documents, tick all the supporting documents you are enclosing in this check list, while submitting your documents at the Embassy.</p> <p>(4) Book an appointment – link</p> <p>(5) Book prepaid airway bill with DHL Express Courier service (in the Netherlands for receiving processed documents. This should be submitted along with an A4 size self-addressed envelope</p> <p>(6) Submit application for VISA along with necessary documents and prepaid self-addressed envelope at Embassy of India, Oranjestraat 12, 2514 JB The Hague.</p> <p>(7) Important Note: Please ensure that all necessary documents/ photograph with specified dimensions mentioned on Visa website are duly uploaded on the Visa website.</p>
Processing Time	Usual processing time is 6-8 working days. Please refrain from making enquiries during this period. The applicant may apply for an E-visa for

	emergency travel.
Fees	Please visit the link
Delivery	Processed document will be dispatched via the prepaid courier provided with the application. Counter collection at the Embassy will not be entertained.

Note:

1. Visa is granted only after consideration of all details provided by the applicants. It is not automatic and guaranteed. Visa fee is not returned if visa is not granted.
2. The Mission would consider refund of Visa fee to the applicants only in cases where excess/multiple visa fee payment was done over and above the prescribed visa fee for all regular paper visa granted by the Mission. Shri Devender Arya, Counsellor (Cons.), would be the nodal officer for all refund claims submitted to the Mission. The affected applicant should make a refund claim either by submission of claim at the Mission or sending an email to [cons\[dot\]thehague\[at\]mea\[dot\]gov\[dot\]in](mailto:cons[dot]thehague[at]mea[dot]gov[dot]in). The Mission will endeavor to settle all claims within 07 working days after the receipt of refund requests. No refund claim will be entertained after 3 months of such payment.
